AGREEMENT AND RELEASE FROM LIABILITY

In connection with participation in the 5k Walk, the undersigned agrees to the following:

1. Voluntary Participation: I acknowledge that I have voluntarily applied to walk in the 5k Walk. I certify that I am in good health and fully capable of participating in the 5k Walk and acknowledge that I have been notified that I should not participate in the 5k Walk unless I am medically able to do so.
2. Publicity Waiver: I hereby grant permission to SN USA to use any photographs, motion pictures, recordings or any record of this event for any legitimate purposes and verify this statement.
3. Assumption of Risk: I AM AWARE THAT PARTICIPATING IN THE 5K WALK ENTAILS RISK, INCLUDING, BUT NOT LIMITED TO, THE POSSIBILITY OF SLIPS AND FALLS, SCRAPES, TWISTS AND JOLTS THAT COULD RESULT IN SCRATCHES, BRUISES, CONTACT WITH OTHER PARTICIPANTS, EFFECTS OF WEATHER, TRAFFIC AND COURSE CONDITIONS, SPRAINS, LACERATIONS, FRACTURES, CONCUSSIONS, OR, IN EXTREME CASES, EVEN DEATH. I AM VOLUNTARILY PARTICIPATING IN THESE ACTIVITIES WITH KNOWLEDGE OF THE DANGER INVOLVED, AND AGREE TO ACCEPT ANY AND ALL RISKS OF INJURY OR DEATH.
4. SNUSA Affiliates: SNUSA Affiliates include SNUSA officers, directors, administrators, volunteers, contractors, agents, successors, predecessors, subsidiaries and assignees.
5. Release: I hereby agree that I, my assignees, heirs, distributees, guardians, and legal representatives will not make a claim against, sue, or attach the property of SNUSA or any of SNUSA Affiliates for injury or damage resulting from any acts of SNUSA or its Affiliates in connection with my training for and participation in the 5k Walk, even though the liability may arise from the negligence or carelessness on the part of persons named in this agreement. I hereby release SNUSA and the Affiliates from all actions, claims or demands that I, my assignees, heirs, distributees, guardians and legal representatives now have or may hereafter have for injury or damage resulting from my training for and participation in the 5k Walk.
